



# AFSC Connect Contest Eligibility

## How to Enter

Eligible participants are automatically entered to win one of six (6) AFSC prize packs when they log in and use a feature of AFSC Connect from May 1, 2020 – November 30, 2020.

Participants will receive a one-time entry for each of the following transactions made during each eligibility period:

- Filing an Insurance Land Report in AFSC Connect
- Requesting an estimate for Straight Hail Insurance in AFSC Connect
- Purchasing Straight Hail Insurance in AFSC Connect
- Reporting a claim for Straight Hail Insurance in AFSC Connect
- Requesting a Revolving Loan Disbursement in AFSC Connect
- Submitting AgriStability Forms in AFSC Connect
- Sending AFSC a document in AFSC Connect
- Filing Insurance Harvested Production Report in AFSC Connect
- Chatting with AFSC in AFSC Connect

## Eligibility periods

- One (1) prize for AFSC Connect transactions made May 1, 2020 – June 30, 2020
- One (1) prize for AFSC Connect transactions made July 1, 2020 – July 31, 2020
- One (1) prize for AFSC Connect transactions made August 1, 2020 – August 31, 2020
- One (1) prize for AFSC Connect transactions made September 1, 2020 – September 30, 2020
- One (1) prize for AFSC Connect transactions made October 1, 2020 – October 31, 2020
- One (1) prize for AFSC Connect transactions made November 1, 2020 – November 30, 2020

## The Draw

The draw will be made from eligible AFSC Connect transactions during the prescribed period. Odds of winning depend on the number of eligible entries received. All door prizes will be awarded pursuant to a draw done by or with AFSC staff from eligible entries within one week following the correlating closing date.

Winners will be notified by e-mail or telephone. In the event a door prize winner does not respond to the prize notification within ten (10) business days of the attempted notification, declines the prize or is ineligible for the prize for any reason, another winner will be randomly chosen from the remaining eligible entries.

## **Eligibility**

This draw is open to individuals who:

- (i) Are legal residents of Alberta;
- (ii) Are at least 18 years of age on the day of the draw; and
- (iii) Are an active client with AFSC in good standing;
- (iiii) Have logged in and used a feature of AFSC Connect.

## **Exclusion of Eligibility**

Employees and representatives of AFSC, affiliated corporations and other persons, as well as members of their households and their immediate families, are not eligible to win a door prize.

## **Door Prizes**

The door prizes must be accepted as awarded. No substitutions or alternations of the prizes are permitted nor will any cash equivalent be paid. AFSC reserves the right, in its sole and absolute discretion, to limit the number of prizes offered and to accept, withdraw, or decline any prize.

## **General Terms and Conditions**
