

AFSC Connect Contest Eligibility

How to Enter

Eligible participants are automatically entered to win one of two AFSC prize packs when they log in and use AFSC Connect to apply for phase two of the 2021 Canada-Alberta Livestock Feed Assistance AgriRecovery initiative.

Participants will receive one entry for each of the following transactions made during the eligibility period:

• Applying for phase two of the 2021 Canada-Alberta Livestock Feed Assistance AgriRecovery initiative.

Eligibility periods

- Two (2) prize packages are available to be won: a Milwaukee 18V impact wrench with grease gun combo or a Dewalt 20V grease gun kit
- The contest applies to phase two applications completed between January 5, 2022 January 31,
 2022

The Draw

The draw will be made from eligible AFSC Connect transactions during the prescribed period. Odds of winning depend on the number of eligible entries received. All door prizes (prize packages) will be awarded pursuant to a draw done by AFSC staff from eligible entries within one week following the contest closing date.

Winners will be notified by email or telephone. In the event a door prize (prize package) winner does not respond to the prize notification within 10 business days, declines the prize or is ineligible for the prize for any reason, another winner will be randomly chosen from the remaining eligible entries.

Eligibility

This draw is open to individuals who:

- (i) Are legal residents of Alberta;
- (ii) Are at least 18 years of age on the day of the draw; and
- (iii) Are an active client with AFSC in good standing;
- (iv) Have logged in and completed their phase two 2021 Canada-Alberta Livestock Feed Assistance AgriRecovery initiative in AFSC Connect.



Exclusion of Eligibility

Employees and representatives of AFSC, affiliated corporations and other persons, as well as members of their households and their immediate families, are not eligible to win a door prize (prize package).
