These are the proposed changes for the 2020 Program Year currently being reviewed.

From the Canadian Agricultural Partnership Guidelines:

4.3.2 Private insurance payments

- 1. Indemnity payments from private insurance programs that are fully producer-funded are nonallowable in the Program Year Margin and allowable in the Reference Margin where they relate to:
 - price or revenue insurance associated with the sale of allowable commodities
 - price insurance associated with the purchase of allowable expenses
 - production insurance covering the production of allowable commodities (e.g. private hail insurance)
 - other income insurance, such as margin-based or guaranteed minimum income insurance
- 2. Indemnity payments from private insurance programs not outlined above, that compensate Participants for the replacement of eligible agricultural commodities or allowable expense items, are included as allowable income in both the Program Year Margin and the Reference Margin (e.g. payments for inputs destroyed by fire).

Code 407: This new code will cover the hail insurance that was moved from the Agrilnsurance codes. It has the same treatment as code 661. For AgriStability, it will be non-allowable in the program year but allowable in the reference years. It will remain allowable for AgriInvest.

Code 681: This new code will be allowable for both AgriStability and AgriInvest: Indemnity payments from private insurance programs not outlined above, that compensate Participants for the

replacement of eligible agricultural commodities

Code 406: This code is allowable for AgriStability in both the Program Year and the Reference Margin but non-allowable for Agilnvest: Indemnity payments from private insurance programs for the replacement of allowable expense items.

Code 661: Covers all indemnity payments outlined in #1 under 4.3.2. Amounts would be non-allowable for AgriStability in the program year but allowable in the reference years. It will remain allowable for AgriInvest.

Code 667: The code and description for WLPIP will remain the same; however the treatment will change. For AgriStability, it will be non-allowable in the program year but allowable in the reference years. It will remain allowable for AgriInvest.
